Muga): Honourable Members, allow me to take you through standing Order No. 32 (2) and I read, "*If there is not a quorum present when the Chair is taken at the time appointed for a meeting of the County assembly, immediately after the saying of the Prayer, the speaker shall order the bell to be rung for five minutes, and if no quorum is present at the expiration of the five minutes, the speaker may direct that the bell be rung for a further five minutes and if there is still no quorum present, the Speaker shall adjourn the county assembly forthwith to the next sitting.*"
