PRAYER

The Speaker (Hon. Oraro): Serjeant-at-Arms kindly ring the quorum bell for the first five minutes. Honourable James Omollo kindly whip the Members who are out. In the meantime, no Member will leave the Chamber until the end of that whipping.

(Quorum bell rung for the first five minutes)

The Speaker (Hon. Oraro): Serjeant-at-arms, again, kindly ring the bell for a further five minutes.

(Quorum bell rung for a further five minutes)

The Speaker (Hon. Oraro): Honourable James Omollo, kindly approach the Chair.

(The Speaker consults with Hon. James Omollo)

(Hon. James Omollo crosses the Floor and takes his seat)

The Speaker (Hon. Oraro): Honourable James Omollo, kindly confirm whether we have a quorum,

Hon. Omollo (MCA, West Nyakach): Thank you, Mr. Speaker, we do not have a quorum.

The Speaker (Hon. Oraro): Honourable Members, first, I want to refer you to the provisions of Order No. 32(2) of the Kisumu County Assembly Standing Orders and I want to read it verbatim. It is about quorum on the commencement of the County Assembly, and I will read two parts of it which states that:

"If there is not a quorum present when the Chair is taken at the time appointed for a meeting of the County Assembly, immediately after the saying of the Prayer, the Speaker shall order the bell to be rung for five minutes; and if no quorum is present at the expiration of the five minutes, the Speaker may direct that the bell be rung for a further five minutes; and if there is still no quorum present, the Speaker shall adjourn the County Assembly forthwith to the next sitting."
