### **PRAYERS**

**The Speaker** (Hon. Oraro): Afternoon Hon. Members, pursuant to the provisions of County Assembly Standing Order No. 32 (2), I request the Serjeant-at-Arms to ring the Quorum Bell for the first five minutes.

*(Quorum Bell rung for the first five minutes)*

**The Speaker** (Hon. Oraro): Hon. Members, citing the provisions of Standing order No. 33 (2), I instruct that the Serjeant-at-Arms to ring the Quorum Bell for eight minutes.

*(Quorum Bell rung for eight minutes)*

**The Speaker** (Hon. Oraro): Hon. Members, I want to make reference to our Standing Order No. 32 (1) and (2) and I read;

**“Quorum at commencement of the County Assembly**

*32.(1)A quorum of the County Assembly or of a Committee of the whole County Assembly shall be a third of its Members.*

*(2) If there is not a quorum present when the Chair is taken at the time appointed for a meeting of the County Assembly, immediately after the saying of the Prayer, the Speaker shall order the bell to be rung for five minutes, and if no quorum is present at the expiration of the five minutes, the Speaker may direct that the bell be rung for a further five minutes and if there is still no quorum present, the Speaker shall adjourn the County Assembly forthwith to the next sitting.*

**The Speaker** (Hon. Oraro): Hon. Members, I did direct that the Quorum Bell be rung for five minutes. Further directed that again the Bell be rung but not for five minute but for eight minutes and per the arrangement available I can confirm that we do not have the requisite quorum to transact business.

**The Speaker** (Hon. Oraro): Hon. Members, guided by the above Standing Order, I want to direct that the House stands adjourned to Thursday, 03<sup>rd</sup> December, 2020 at 02:30 p.m.
