Hon. Agolla: Thank you Mr. Speaker. A few hours ago, I was in the precincts of the Assembly and it was brought to the attention of I together with Honourable Okiri that, an incident has taken place in my ward around Ongalo Area. Some two youths were trying to excavate murram in a certain quarry in that area and unfortunately, there was a land slide and they were covered with the murram that they were trying to excavate.

Mr. Speaker, we rushed to that scene, fortunately, we found one of the youths had been rescued and taken to the hospital. We supported the community to try and rescue the other excavator whom

was also seriously injured. We rushed the victim to Kisumu County Referral Hospital. Unfortunately, when we arrived at the facility, we were informed that the first victim had succumbed. Mr. Speaker, I want to ask this House for their prayers. Equally, I want to really appreciate the County Government of Kisumu Fire Department for their quick response. Mr. Speaker, it took us approximately 15 minutes to see the Kisumu County Ambulance ready to assist and save lives. Without forgetting, I also want to thank the investors in that particular area undertaking their work, notably Shajanand, Heigher Bishan and Virsham Companies. They similarly responded with haste and gave us their machines that assisted us rescue and save life.

Mr. Speaker, my main concern as a Member of this County Assembly is to request for your prayers so that the brother who was injured for a quick recovery. I also want to thank staff from the JOOTRH. They took quick measures and interventions because the boy was immediately admitted by the time of our leaving. Thank you Mr. Speaker that was the Statement I wanted to raise as an elected Member of the County Assembly representing South West Kisumu Ward.
