Leader of Majority (Hon. Ooko, MCA, Ahero Ward): Thank you Mr. Speaker. Pursuant to the provisions of the County Assembly of Kisumu Standing Order No. 41 (2) (a) and (b), I wish to seek a Statement from the Chairperson of Water, Environment and Natural Resources Committee on storm water management and general cleanliness of Ahero Town.

Mr. Speaker, In the Statement, the Chairperson should give details or comprehensive plans on how County Department of Water, Environment and Natural Resources on proper control and management of storm water in Ahero Town that has been a perennial problem with blocked

sewerage lines characterized with unprecedented water and sewerage backflows that floods the shops during the rainy season

Mr. Speaker, I would also like the Chairperson to explain why the Department has not been able to provide cleaning arrangements leading to unfounded filth in public health and related risk in Ahero Town. Thank you, Mr. Speaker.

The Temporary Speaker (Hon. Okumu, MCA East Seme Ward): Thank you Honourable Leader of Majority. I acknowledge that your Statement was duly received and approved. I want to give an opportunity to Chair of the Committee to say something on the same.

Hon. Dede (MCA, Kisumu North Ward): Thank you Honourable Speaker. I want to request that the committee be given more time to look into this matter and table a comprehensive report on the same. Twenty-One days will be enough.

The Temporary Speaker (Hon. Okumu, MCA East Seme Ward): Honourable Members, I want to commit this report to the Water, Environment and Natural Resources Committee and you bring a comprehensive report on the same in the next Fourteen days. Remember, we are focusing a lot of rains in the Western part of Kenya, you therefore need to act with speed to address the matter before the Honourable Member is overwhelmed. Thank you.
