RECOGNIZING that Kisumu County Assembly Standing Orders No. 154(2) provides for the appointment of a new County Assembly Business Committee;

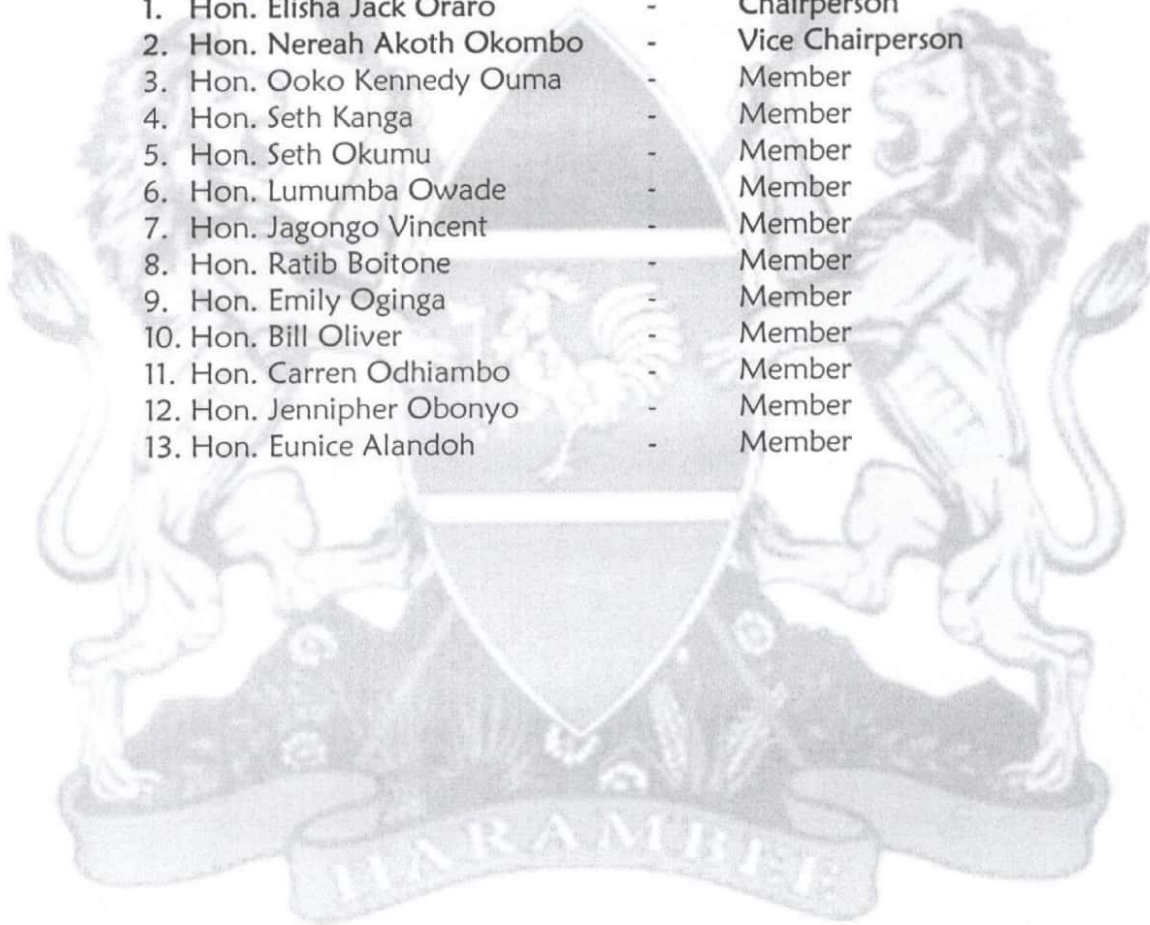

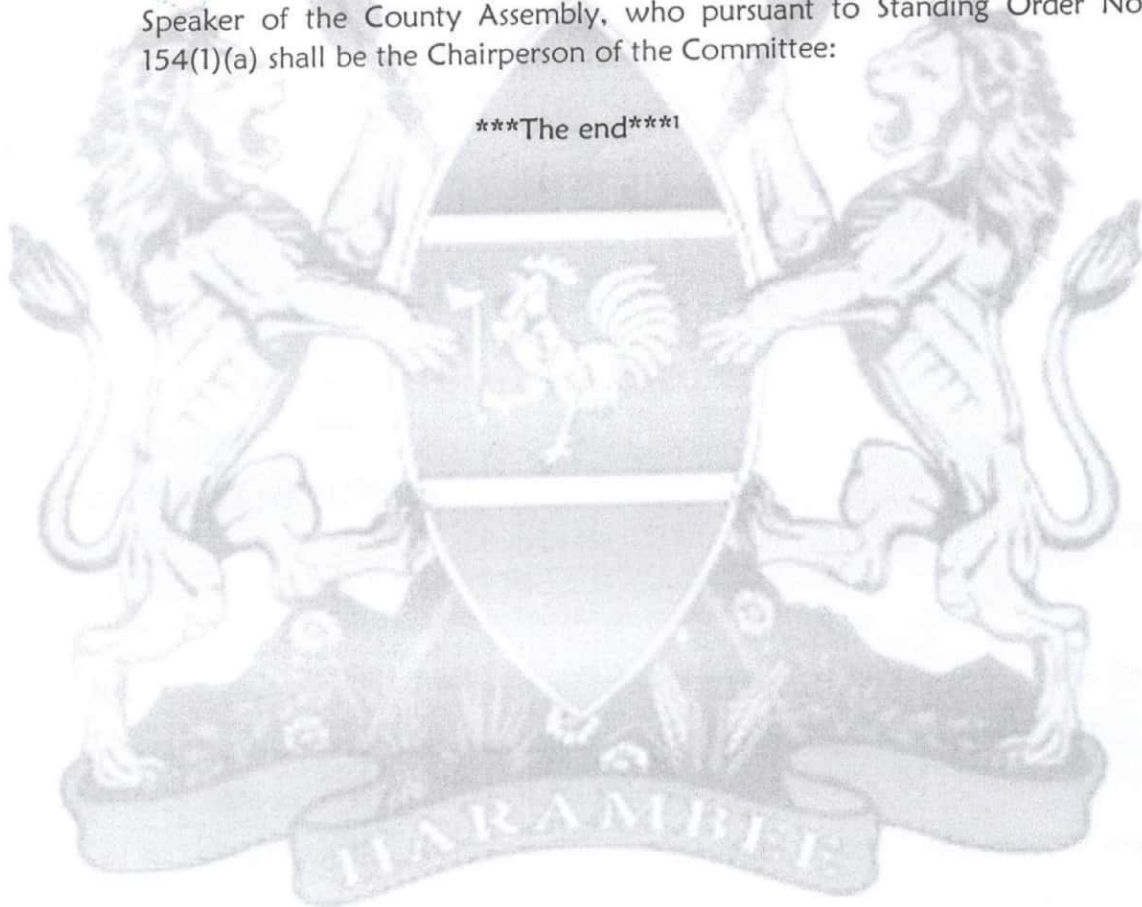
