AWARE THAT Standing Orders No. 25 of the Kisumu County Assembly Standing Orders provides; (1) *Except for the Session commencing immediately after a General Election, the regular Sessions of the County Assembly shall commence on the second Tuesday of February and terminate on the first Thursday of December.*

FURTHER AWARE THAT Sub section (3) of Standing Orders No. 25 states that *subject to paragraph (1), the County Assembly shall continue to be in session and may adjourn for such number of days as it may determine in its calendar.*

NOTING THAT *Despite paragraphs (1), (2) and (3), a period of three months shall not intervene between the last sitting of the County Assembly in one Session and the first sitting thereof in the next Session.*

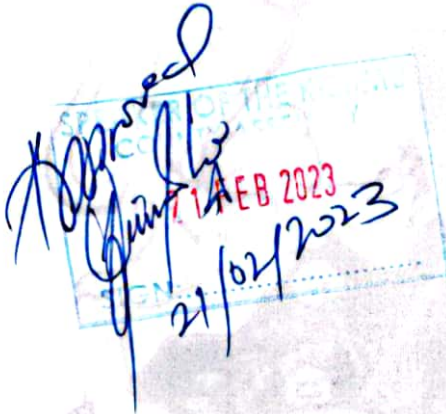
