A. STATEMENT REGARDING ALLEGATIONS OF IRREGULAR RECRUITMENT OF STAFF AT JOOTRH.

Pursuant to Standing Order 41(2, a, b), I rise to seek a statement from the Chairperson of the Committee on Administration of Law, Justice, Constitutional Affairs, Good Governance and Security on allegations of irregular recruitment of staff at the Jaramogi Oginga Odinga Teaching and Referral Hospital without following the due process and in utmost disregard of the role and functions of the County Public Service Board.

Hon. Speaker, I am aware from my own knowledge and that of my constituents, information that I verily believe to be true, that the management of Jaramogi Oginga Odinga Teaching and Referral Hospital has recently irregularly recruited different cadres of staff within the facility contrary to the provisions of Sections 55, 56 & 59 of the County Governments Act 2012.

In this statement request, the Committee Chairperson should;

- i. Provide a comprehensive report from the Department of County Administration and Public Service, detailing the circumstances, authorizations, justifications and recruitment procedures followed in the recent irregular recruitment of staff by the -
