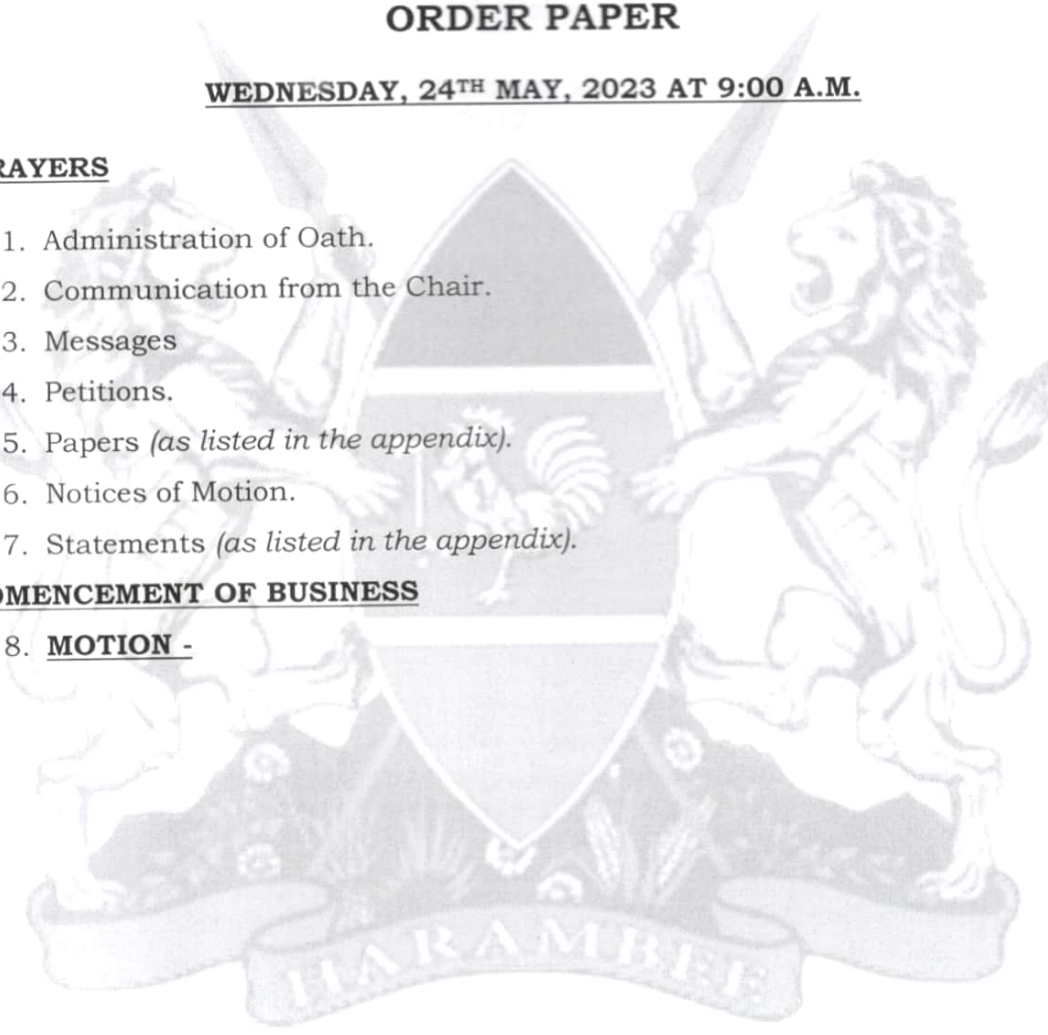

2. STATEMENTS.

- i) **Statement on the perennial road accidents claiming lives at Nyamasaria overpass at Kachok.**  
*(Hon Zachariah Okoyo, MCA Central Kisumu ward)*

Pursuant to Standing Order 41(2, a, b), I rise to seek a statement from the Chairperson of the Committee on Roads, Public Works & Transport on the perennial road accidents claiming lives at the Nyamasaria overpass at Kachok.

Hon. Speaker, aware that the road is under Kenya National Highways Authority (KENHA) which is a National Government agency, the lives being lost are those of residents of Kisumu County whom we have obligations to represent and intervene for. There has been witnessed several accidents at the overpass with the latest which occurred on 16<sup>th</sup> May 2023 claiming several lives including a mother and her baby after a trailer veered off and landed on a tuk-tuk causing instant deaths of the passengers and driver. Other grim accidents at the overpass that has claimed several lives include: an oil tanker accident that claimed 7 lives on 23<sup>rd</sup> Jan 2018, a trailer accident on 15<sup>th</sup> July 2022 that claimed yet other lives. just but to mention a few.

In this statement request, the Committee Chairperson should;

1. Initiate a comprehensive oversight with an intention of consulting various relevant stakeholders including but not limited to KENHA in order to provide a report to this House on the causes of accidents at the Kachok - Nyamasaria overpass and the action(s) that the relevant agencies have taken to mitigate the problem.

ii) **Statement on continued closure of Jomo Kenyatta Sports Ground.**

*(Hon Benson Adega, MCA Kajulu ward).*

Pursuant to Standing Order 41(2, a, b), I rise to seek a Statement from the Chairperson of the Committee on Sports, Culture and Community Services on the status of the continued closure of Jomo Kenyatta Sports Ground.

Hon. Speaker, the sports facility has been closed for long even after undergoing a facelift of infrastructure, open spaces and environmental beautification. Instead of being opened for use by members of the public for its intended purpose, the Jomo Kenyatta Sports Center has since been left to little/ inadequate attention with overgrown shrubs and bushy environment with a risk of providing habitation for wild animals. The continues non-utilization of the facility is causing the County lots of losses in revenue, talent and wastage as well as lack of/inadequate open spaces for recreational activities.

In the statement, the Chair should;

1. Explain why Jomo Kenyatta Sports Ground continues to be closed and why the facility cannot be immediately opened for use by members of the public for recreational and related intended objectives
