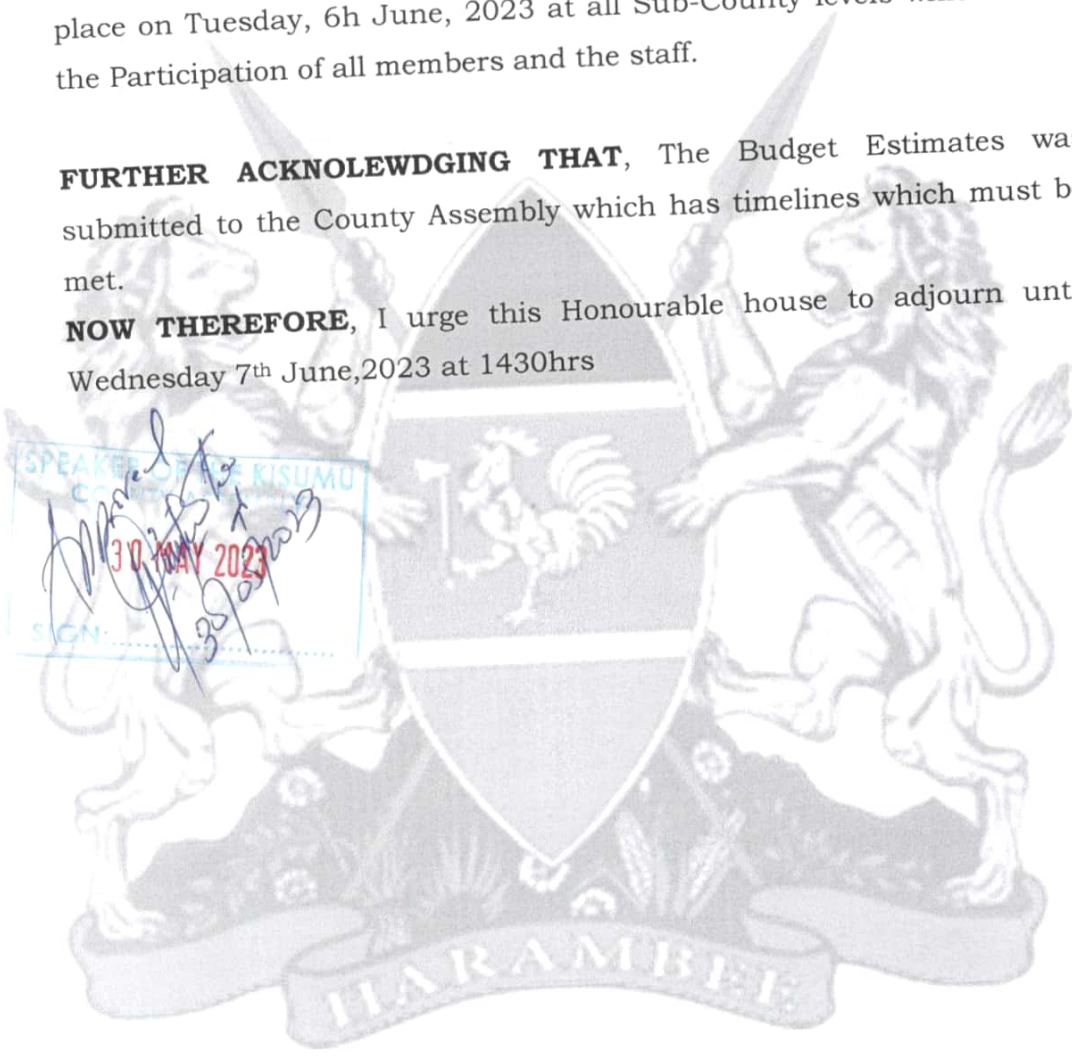
**FURTHER AWARE THAT** Public Participation is a fundamental right enshrined in the 2010, Kenyan Constitution.
