Kisumu County government advertised to employ a total of 86 (eighty-six) Assistant ECDE Teachers (III), advertisement number KCASB/01/2021/01, to fill the vacant positions on January 1st, 2021. A total of 435 (four hundred and thirty-five) candidates were shortlisted for the interviews from 25th June to 7th July, 2021.

Mr. Speaker it is the public domain that till today no report has been given by the County Government of Kisumu about candidates who were successful after the interviews despite conducting the exercise successfully.

Let the committee inquire into and report on;

- a) The number of the Assistant ECDE teachers who were successful after the interviews.
- b) The comprehensive report of the whole process including the total cost incurred during the said process.
- c) Reasons why the ECDE teachers who were successful in the interviews have not been engaged to date.
