MOTION

MOTION FOR APPROVAL OF THE INTEGRATED URBAN DEVELOPMENT PLAN (IDeP) AND ANNUAL INVESTMENT PLAN (2024/2025)

AWARE that Article 184 of the Constitution of Kenya provides for the governance and management of urban areas and cities through the Urban Areas and Cities Act, 2011 and that Sections 104 and 109 of the County Governments Act, 2012 require every County to have plans to guide, harmonize and facilitate development within the County;

FURTHER AWARE that Section 36 of the Urban Areas and Cities Act, 2011 requires Urban areas and Cities to develop the Integrated Urban Development Plan (IDeP) which is harmonized with county plans and that implementation of projects and utilization of funds within urban areas must align with the approved (IDeP);

WHEREAS the City of Kisumu has developed an Integrated Urban Development Plan (IDeP) aligned with the objectives of the Urban Areas and Cities Act (Amended 2019) to serve as a blueprint for sustainable growth, addressing critical areas such as land use, infrastructure development, environmental conservation, economic growth, and social equity for the planning horizon of 2024–2034;

AND WHEREAS the Annual Investment Plan (2024/2025) has been prepared as part of the implementation strategy for the IDeP to ensure efficient allocation of resources for priority development projects;

NOTING THAT the said documents were prepared in consultation with relevant stakeholders, and their preparation adhered to statutory guidelines under Section 23 of the Urban Areas and Cities Act;

COGNIZANT of the importance of these plans in enabling access to funding, ensuring compliance with statutory mandates, and advancing the city's development agenda;

ACKNOWLEDGING that these documents have undergone rigorous public participation and stakeholder engagement and further acknowledging that these Plans have been reviewed and approved by the City Board of Kisumu;



NOW THEREFORE, I WISH TO MOVE A MOTION THAT THIS HOUSE RESOLVES AS FOLLOWS:

1. THAT the Kisumu City Integrated Urban Development Plan (IDeP) for the City of Kisumu, covering the period 2024–2034, be approved and adopted as the city’s primary planning document for sustainable urban development.
2. THAT the Annual Investment Plan (2024/2025), outlining specific projects and financial allocations for the implementation of the IDeP in the fiscal year 2024/2025, be approved and adopted.
3. THAT the County Executive Committee Member in charge of Planning and Urban Development and the City Board of Kisumu ensures prompt implementation of the (IDeP) and Annual Investment Plan (2024/2025) and provides quarterly updates to the County Assembly on progress made.
4. THAT this House prioritizes any future legislative and budgetary measures necessary for the successful execution of these plans.
